## COYOTE RIDGE GOLF CLUB

### Membership

Along with a fully paid initiation fee to join Coyote Ridge Golf Club, your membership must remain in good standing for 12 consecutive months from the date of your agreement. **Any violation of club rules or policies is subject to the early termination penalty listed below.**

- Upon written notice of violation of club rules, the early termination fee of **\$1,000.00** will be *automatically* charged to the credit card on file.

After fulfilling one full year of the contractual term, you must sign a new contract to continue as a platinum member at Coyote Ridge Golf Club. Failure to sign a new contract will result in termination of membership and loss of all platinum member privileges. All annual memberships are non-refundable.

### Dues

First month's dues are required at sign-up. After sign-up, the designated dues will be billed to the credit card on file on the last day of each month. All platinum memberships that have not fulfilled the contractual term of one full year in member dues will be deemed as a breach of contract. Contract breaching can lead to legal proceedings including the collection of the remaining due balance along with any additional costs related to the legal proceedings and collections.

### **Alcohol Policy**

Coyote Ridge Golf Club allows for the consumption of alcoholic beverages by its members according to the Texas Alcoholic Beverage Commission laws. Outside alcohol is not permitted on Coyote Ridge premises. All alcoholic beverages must be purchased through Coyote Ridge Golf Club. Any violation of the CRGC alcohol policy could result in membership suspension or termination.

### **Grill 19 Member Discount Policy**

Members have the privilege of dining at Grill 19 at a discounted rate. The following guidelines must be followed when using a membership discount:

- 10% off food and beverages in Grill 19 (this excludes banquets and alcohol).
- Single Membership Package - Only the member is entitled to discount, any guests must pay full price.
- Family Membership Package - Only member and family listed on membership agreement are entitled to discount.
- 10% discount cannot be combined with any other discount, special or promotion in Grill 19, which includes Happy Hour and/or Daily Special.

## **Unpaid Dues**

If a member becomes delinquent for 15 days, he/she will be notified via email about missed payment. All platinum membership privileges will be suspended until the account is paid in full. Member accounts delinquent for 30 days or more will be terminated, and your file will be sent to attorneys for further action. You will be responsible for attorney's fees and court costs incurred.

## **Resignation of Membership**

Platinum membership at Coyote Ridge Golf Club is an annual contract. Members must give a 30-day notice of resignation in order to terminate their contract. The resignation must be in writing and signed by the member for the account to be closed on the books. Otherwise, the account will continue accruing dues and interest each month until written notification has been received. If resignation is due to relocating outside of the area, you are to include the change of address on the written notification.

**Early resignation for platinum memberships is \$1,000.00.**

All memberships are a one-year contract that includes: locker rooms, 15% off food and beverage (excluding alcohol), 25% off golf lessons and a Pro Shop discount of 10% off hard goods and 20% off soft goods. All fees listed do not include tax.
