RULES & REGULATIONS

WELCOME TO COYOTE RIDGE GOLF CLUB

Coyote Ridge Golf Club wants you, the Member, to enjoy utilizing this facility under the Membership in which you have selected. As with any type of "Membership", there are set guidelines that every member is expected to follow. The obligation of enforcing the Rules & Regulations is placed in the hands of the management and staff, whose principal responsibility is to assure you of all courtesies, comforts, and services to which you are so entitled. However, it is further the duty of the Member(s) to know and understand these guidelines, in order to cooperate with the management and staff.

*It is understood that I will comply with and observe
the Rules & Regulations of the Club.*

By becoming a "Member" at Coyote Ridge Country Club, you are signing a Membership Agreement, acknowledging that you know and understand the following:

- *Membership at Coyote Ridge Golf Club conveys to the individual and the immediate family (spouse and dependents under the age of 25 living at home) the right to use any of the designated Club facilities, according to the Rules & Regulations of Coyote Ridge Golf Club and the classification of Membership purchased.*
 - *ALL Memberships are offered at the discretion on the Club and Club owner.*
 - *ALL Memberships may be amended, changed, revoked, or discontinued at any point in time at the sole discretion of the Club and Club owner.*
 - *Membership dues and fees do NOT confer any ownership of the Club, its property or its assets.*
 - *Members must conduct themselves in a manner consistent with the tradition of the game of golf.*
 - *Members must refrain from any type of behavior that violates the Coyote Ridge Golf Club Code of Business Conduct Policy.*
 - *ANY conduct detrimental to the Golf Club, its employees, or its fellow members may result in suspension or termination of Membership privileges.*

RULES & REGULATIONS

ALCOHOL POLICY

Coyote Ridge Golf Club allows for the consumption of alcoholic beverages by its Members according to the laws of the Texas Alcoholic Beverage Commission.

- Outside alcoholic beverages are NOT allowed on the property of Coyote Ridge Golf Club
- ALL alcoholic beverages must be purchased through Coyote Ridge Golf Club

Abuse of Coyote Ridge Golf Club alcohol beverage policy is NOT tolerated and any violation of the Coyote Ridge Alcohol Policy could result in Membership suspension or termination.

MEMBER DISCOUNT POLICY IN GRILL 19

As a Platinum Member of Coyote Ridge Golf Club, Member's have the privilege of dining at Grill 19, at a discounted rate. The following are stipulations and guidelines in which they must follow when using their discount at Grill 19:

- Members are allowed a 15% discount on food and non-alcoholic beverages
 - This EXCLUDES banquets and alcohol
- For *Single Membership Package*, ONLY the Member is entitled to discount
 - Guests must pay at full-price, they are NOT allowed discounted pricing
- For *Family Membership Package*, ONLY Member and family members listed on the Membership Agreement are entitled to discount
 - Guests must pay at full-price, they are NOT allowed discounted pricing
- 15% discount is NOT valid and/or cannot be combined with any other discount, special or promotion in Grill 19, which excludes Happy Hour and/or Daily Special





RULES & REGULATIONS

ONE-YEAR MEMBERSHIP COMMITMENT OPTION

I hereby accept a one year Membership Commitment in lieu of a fully paid initiation fee to join Coyote Ridge Golf Club. I fully understand that by accepting this option, I must maintain good standing in my Membership Account, under the selected Membership Classification that I choose, for a period of 12 consecutive months from the date of this agreement. After I have fulfilled my full year of the contractual term, I must sign a new contract upon my anniversary date of the current contract to continue as a Member at Coyote Ridge Golf Club. Failure to resign a new contract, of another full year term, will result in termination of my contract and the loss of all Membership privileges. Any account terminated by Coyote Ridge Golf Club due to a violation of Coyote Ridge rules or policies is subject to early termination penalty, as stated below. The one year Membership Commitment may be cancelled prior to the maturity date with an early termination option, as follows:

1. Upon written notice of early termination or upon termination of the Membership by Coyote Ridge Golf Club for violation of Club rules or policies. *Early termination fee of \$1,000.00 will be automatically charged to the credit card on file.*
2. Annual Memberships are NON-refundable
3. ALL Memberships that have NOT fulfilled their contractual term of a full year in Member dues will be deemed as a *breach of contract*. It can lead to legal proceedings including, collections of the remaining balance of Member dues, along with any additional costs related to the legal proceedings and collections.

RULES & REGULATIONS

MEMBERSHIP DUES

- First months dues are required at sign up
- Partial months dues will be prorated to the beginning of the month
- After sign up the designated dues, according to the specific Membership Classification you have chosen, will be billed to the credit card on file the last day of each month
- *Monthly Memberships:* Early resignation or non-payment of dues will result in a fee of \$750.00. If a Member becomes 15 days delinquent, he/she will be notified via email regarding the missed payment. Privileges will be suspended at Coyote Ridge Golf Club until the account has been paid in full. When the account is 30 days or more delinquent, the member will be on "Terminated" status and the account will be sent to attorneys for further action.
- Members can upgrade or downgrade their current Member tatus, upon a written request and approval per Coyote Ridge Management.
- Upgrade and/or downgrade fee is \$75.00 and will be charged every time the Membership Classification is changed.

I fully acknowledge and understand the billing procedures, as stated above, and agree to the conditions set forth. Additionally, I authorize Coyote Ridge Golf Club to charge my MasterCard, Visa, Discover, or American Express for any dues and/or charges that are 60 days or more past due. Finally, I understand that a \$25.00 processing fee will apply to the Membership Account for any disputed credit card charges.





RULES & REGULATIONS

RESIGNATION OF MEMBERSHIP

The Membership Agreement at Coyote Ridge Golf Club is an annual (12-month) contract. However, the Member is allowed to give a 30-day notice of resignation. The resignation must be in writing and signed by the Member in order for the account to be closed on the books. Otherwise, the account will continue accruing dues and interest each month until written notification has been received. If re-locating out of the area, you are to include a change of address on the written notification. *Early resignation fee for monthly Memberships is \$1,000.00.*

I fully acknowledge and understand the Membership Agreement of Coyote Ridge Golf Club as an integral part of the Rules & Regulations of the Club, and agree to be bound by all conditions and policies as set for in the aforementioned paragraphs of the Membership Agreement.

I further understand and acknowledge that occasionally, the Club may amend its policies, rules, regulations, and Membership offering, at its sole and absolute discretion. The Club is NOT obligated to provide Membership privileges indefinitely and may cancel any Membership with a thirty day written notice to the Member.
